

TIPS TO MAKE A DIFFERENCE

- ◆ Compost food products at home or town provided bins (see sign at compost bins for approved list of compostable products)
- ◆ Reduce lunch waste by buying snacks in large bags and putting them into small, reusable containers.
- ◆ Use a reusable lunch box instead of disposable paper bags.
- ◆ Whenever possible, purchase products with minimal packaging.
- ◆ Reuse canvas, paper or plastic bags to bring home purchases.
- ◆ Buy recycled products—the greater the demand, the more products will be made with recycled materials.
- ◆ Recycling—it's not just in the kitchen. Recycle your shampoo bottles and toilet paper rolls!

The Mandatory Recycling Act has been in effect in CT since 1991. **Everyone is required to recycle by law** and the Transfer Station accepts a large majority of common household/business items for recycling.

Garbage

The Town of Portland does not collect garbage or recyclables. Residents may contract with a residential private hauler for curbside service or bring their garbage and recyclables to Portland's Transfer Station facility. All garbage must be put in Portland "Pay Per Bags."

Plastic bags with ties are sold in 3 sizes:

Small (15 gallon) \$ 2.00

Medium (30 gallon) \$ 4.00

Large (45 gallon) \$ 5.00

Bags are available at the Transfer Station, Collector of Revenue's Office & Adams Market.

Permits are available for Portland residents only and are valid through June 30th. Permits can be obtained at the Public Works Office at Town Hall & at the Transfer Station. Permits must be affixed in the lower right hand corner passenger side of the windshield.
